NOTIFICATION

Whereas the draft of the following rules further to amend The Karnataka Legal Metrology (Enforcement) Rules 2011 was published as required by sub-section 4 of section 53 of the Legal Metrology Act 2009(Central Act 1 of 2010) in Notification no: FCS 15 EBT 2020(e-office), dated 08.06.2021 in part IV-A of the Karnataka Gazette inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of publication in the official gazette.

And whereas the said Gazette was made available to the public on 10.06.2021.

And whereas, the objections and suggestions received have been considered by the State Government.

Now, therefore, in exercise of the powers conferred under section 53 of the Legal Metrology Act 2009(Central Act 1 of 2010), and after consultation with the Central Government, the Government of Karnataka hereby makes the following Rules, namely:-

RULES

1. Title and commencement:

- These rules may be called the Karnataka Legal Metrology (Enforcement) (Amendment) Rules, 2021.
- 2. They shall come into force from the First day of January 2023.
- 2. (i) In rule 3, in sub-rule (1) the following proviso after the existing proviso shall be inserted, namely:

Provided further that no person shall be granted a repairing license unless such person possesses such educational qualification/technical competency, and such other conditions as may be specified by the Controller from time to time.

3. (ii) In rule 3 of the said rules, for the sub-rule (4), the following shall be substituted, namely: -

Every license issued to a Manufacturer, Dealer and Repairer shall be valid for a period of two calendar years and may be renewed for a period every two calendar years, by the Controller or such other officer as may be authorized by him in this behalf on payment of fee as specified in the schedule IV.

4. In rule 3 of the said rules after the sub rule 12 a new sub-rule 13 shall be inserted as follows;

Suspension and cancellation of licence granted:

(1) The Controller or such other officer authorized by him on his behalf may, if he has any reasonable cause to believe that the holder of any licence issued, renewed or continued under this Act has made any statement in, or in relation to, any application for the issue, renewal or continuance of the licence, which is incorrect of false in any material particular or has contravened any provision of the Act or any rule or order made thereunder, suspend such licence, pending the completion of any inquiry against the holder of such licence:

PROVIDED that no such licence shall be suspended unless the holder thereof has been given a reasonable opportunity of showing cause against the proposed action:

PROVIDED FURTHER that where the inquiry referred to in this sub-section is not completed within a period of three months from the date of suspension of a licence, such suspension shall, on the expiry of the period aforesaid, stand vacated.

(2) The Controller or such other officer authorized by him on behalf may, if he is satisfied, after making such enquiry as he may think fit, that the holder of a licence has made a false or incorrect statement of the nature referred to in sub-rule (1), or has contravened any law or order referred to in that sub-section, cancel such licence:

PROVIDED that no such licence shall be cancelled unless the holder thereof has been given a reasonable opportunity of showing cause against the proposed action.

- (3) Every person whose licence has been suspended shall, immediately after such suspension, stop functioning as such licencee and shall not resume business as such licencee until the order of such suspension has been, or stands, vacated.
- (4) Every licencee whose licencee has been suspended or cancelled shall, after such suspension or cancellation, as the case may be, surrender such licence to the authority by which such licence was issued.

(5) Every licencee whose licence has been cancelled shall, within a period of thirty days from the date of such cancellation, or within such further period, not exceeding three months from such date, as the Controller or such other officer authorized by him on behalf may, on sufficient cause being shown, allow, dispose of the weights or measures which were in his possession, custody or control on the date of such cancellation and in the event of his failure to do so, the Controller or any other officer authorized by him, in writing, in this behalf, may seize and dispose of the same and distribute the proceeds therof in such manner as may be prescribed.

5. In the Rule 3 of the said rules the existing rule 3(14) is omitted and substituted with the following:

Rule 3(14): Use of weights only or measures only or number only in certain cases.

Except in the cases of commodities specified in Schedule - XIA, the declaration of quantity in every transaction, dealing or contract, or for protection shall be in terms of the unit of-

- Weight, if the commodity is solid, semi-solid, viscous or a mixture of solid and liquid;
- b. Length, if the commodity is sold by linear measure;
- c. Area, if the commodity is old by area measure;
- d. Volume, if the commodity is liquid or is sold by cubic measure; or
- e. Number, if the commodity is sold by number.

Provided that the Controller, Legal Metrology shall issue instruction/directions/orders on use of specific type of weight or measure or number from time to time for different trade/transactions:

- i. Areas
- ii. Class of undertaking
- iii. Class of Goods
- iv. Class of users of weights and Measures.

6. Insertion of New Rule 7A: After rule 7 New Rule 7A is added.

- Rule 7A: Congnizance of offences: Notwithstanding anything contained in code Criminal Procedure code 1973.
- a. No court shall take congnizance of offence punishable under the Act and the Rules made thereunder except upon a complaint in writing made by

- i. The Controller
- Any other Legal Metrology Officer authorized in this behalf by the Controller by general of special order.
- iii. Any person aggrieved or
- recognized Consumer Association whether the person aggrieved is a member of the Association or not.
- b. No Court inferior to that of a Metropolitan magistrate or a judicial Magistrate of the first class shall try the offences punishable under the Act & the Rules made thereunder.
